

Immediately & came to college from Nellore and spoken to my daughter, college Perneipal and Anti-Ragging committee


So, In future anything goes wrong with my daughter I will take complete responsibility and agree what ever action taken against her by the authorities





As per the information received from your "Anti-Ragging helpline" dated 11.09.2017 we have called Miss. Teja third year BDS (class representative) and miss. Lohitha third year BDS (cultural representative) and asked for an explanation as to the events that have been taking place over the last few days. In addition to this all the second year students have been called individually and have been counseled to made them feel safe and to an extent that they know the authorities at GSL dental college are with them and action will be taken on their complaint.

The Details as the Investigations

- 1. The issue is between the 2nd year BDS students and 3rd year BDS students
- 2. The 2nd year students have gone to the 3rd year students room for instruments.
- 3. The 3rd year students have refused to share their instruments with 2nd year.

- 4. The 3rd year student have asked the 2nd year their self details and along with them they have asked to sing songs and tell their famous heros filmi dialogues if they want them to give their instruments.
- A second year BDS students by name Miss Tushara Priya of second year has been called by Miss Lohitha of third year BDS from her room at 10.30pm and insisted she comes even though she is not feeling well.

Based on the above said facts it has been concluded that there were exchange of words and inconvenience caused to the II years by the III years. Both Tejaswini and Lohitha of III BDS have been asked to call their parents for which the parents responded immediately and came. Both these students along with their parents have been counseled by the committee. As this is the first incidence of this nature the students were issued a memo to the effect that any further involvement and indulgement in any form of ragging will attract severe punishment which may go up to debarring from the college. The parents of the III year students have also be instructed to closely monitor their children and counseled them and in addition have been asked to write a letter to that effect. Miss.Lohitha has been ask to apology for what has being done and has been strictly warned again in presence of all the committee members. Keeping the students future in mind the anti Ragging committee has decided to amicably resolve the above said issue and council all of them and make them feel safe to an extent that they know the authorities of GSL Dental college are with the aggrieved and students involved in ragging are taken to task.
