MEMORANDUM OF UNDERSTANDING / AGREEMENT

This Memorandum of Understanding (MOU) is made on this day, the 14th February 2019

Between

The GSL Trust - Cancer Hospital & Research Centre, having its office Near Kambala Park, Rajamahendrayaram - 533105 represented by its Managing Trustee, Sri Ganni Bhaskar Rao, aged 63 years, s/o Sri Ganni Satyanarayana Murthy which expression shall include authorized representatives of the GSL Cancer Trust, herein after referred to as First Party

And

Sovernment District Hospital, Rajahmaendravaram, represented by its District Coordinator for Hospital Services & Medical Superintendent, Dr.Tiruvaipati Ramesh Kishore, aged 55 years, s/o Shri Tiruvaipati Ranganayakulu, located at Central Jail Road, Rajamahendravaram-533 105 East Godavari District, Andhra Pradesh which expression shall include authorized representatives of the District Hospital, Rajamahendravaram herein after referred to as Second Party

Whereas, the program for which this MOU is signed is to be known as "Cancer Screening, Treatment and Control Scheme for Godavari Districts". This program aims to reduce the morbidity and mortality due to cancer through health education, early detection and provide effective anti-cancer treatment, if required through Mobile Advanced Medical Unit (MAMU).

Shri Maganti Murali Mohan, Member of Parliament representing Rajahmundry Parliament Constituency in Andhra Pradesh, had keen interest and extended his support by sponsoring from MPLADS the related Equipments required for this Mobile Advanced Medical Unit (MAMU), in order to ensure timely health check of rural population and has handed over the same to Second Party (Medical superintendent, Government District Hospital, Rajahmundry).

The Second Party expressed its inability to carry on with the program, i.e. "Cancer Screening, Treatment and Control Scheme for Godavari Districts" due to non-availability of Cancer related experts, Technical staff, related infrastructure, and in addition to bear the huge running cost of MAMU.

Whereas the **First Party** is a well established entity having Oncology (cancer) experts and a Cancer hospital with all needed infrastructure, technical staff and other allied requirements.

Whereas the **First party** also provided the chassis of the vehicle, Bed Trailer and a Television screen all costing about **Rs.39.90 lakhs**

Whereas the **First party** expressed its willingness to be a part of the project under Public Private Partnership mode for screening, early detection and treatment of cancer to the needy population of Godavari Districts of Andhra Pradesh under Cancer control program under AP State Health Insurance Schemes like Dr.NTR Aarogyasri/Arogya Raksha / Govt. of India schemes, etc.,

OBJECTIVES OF THIS MOU

- a) To identify and establish the roles and responsibilities of both parties and delivery of comprehensive cancer care
- b) To provide health education, diagnostic facilities and treatment for cancer control
- c) To develop the capacity of paramedical health care providers for detection of cancer in early stages.

TERMS AND CONDITIONS OF THIS MOU

- 1. The First Party shall provide the technical manpower VIZ., Doctors, Nursing and paramedical staff for "Cancer Screening, Treatment and Control Scheme for Godavari Districts" and shall maintain the vehicle in proper manner.
- 2. The **First Party** shall prepare and provide informational manuals, pamphlets, power point presentations and video films.
- 3. First Party shall conduct cancer screening camps for breast, cervix and head and neck cancers Free of Cost.
- 4. First party shall provide cancer treatment if required under eligible health insurance schemes at GSL Cancel hospital or refer to other nearby cancer hospital as per the wish of the patient.
- 5. First party shall maintain copy of Medical records of patients screened, diagnosed and treated under the scheme
- 6. Both parties agreed to utilize the said vehicle for 15 days in a month by the first party and 15days in a month by the **second party**
- 7. The **First Party** will provide the vehicle with needed infrastructure and manpower for medical camps at locations agreed mutually. **The second party** shall give at least seven days advance intimation to First Party to organize the cancer screening camp.
- 8. During the operation of the agreement if circumstances arise which call for alteration or modifications of this agreement, the said modifications / alterations will be mutually discussed and agreed upon in writing.
- 9. This agreement shall be valid for fifteen (15) years from the date of entering into this agreement.
- 10. As the life of medical equipment referred in above is around **Five (5) years** this agreement may be reviewed or renewed after, every five years during the tenure by mutual consent. Existing **list of equipment and other assets of the MAMU are annexed.**
- 11. This agreement shall hold good with the successor of the **Second Party** i.e., Medical Superintendent, Govt. District Hospital, Rajamahendravaram or any authority as nominated by the second party herein.
- 12. Any dispute arising with regard to any aspect of this Agreement shall be referred to the District Collector, East Godavari District, Kakinada to settle through mutual consultations and agreements by both the parties to the Agreement.

- 13. The First Party shall be responsible for repairs and maintenance of the said MAMU -mobile clinic.
- 14. The second party agrees with First party to exhibit its logo and name on the mobile clinic.
