As you are already aware that the Corona Virus 2019 (COVID19) constitutes a public health emergency in India and it stands at an important turning point in its fight against COVID-19. This public health emergency in the country calls out to every trained healthcare professional and is an opportunity for dental healthcare professionals to join forces and work towards making the country COVID-free. Dentists and Dental specialists training maintain highest academic standards equivalent any medical professional programs during which they undergo rigorous training to achieve this degree. With structured short-term training trained dentists will be in a position to contribute in the larger public health domain.

In this context, the Deputy Secretary to the Government of India, Ministry of Health & Family Welfare, New Delhi vide his email dated 04.04.2020 has already requested the Dental Council of India to provide the data of dentists registered in the country alongwith their necessary details viz. Name, Address, Mobile Number and Email address.

Name, Address (locality, district and state), Mobile Number and Email Address) to Council's email secy-dci@nic.in, so as to enable this Council to provide the same to the Government of India, Ministry of Health & Family Welfare, New Delhi so that they can serve and contribute in this national calling and march in unison with the Central/State Governments to curb the menace of COVID-19.

This may kindly be treated as most urgent in public interest, and the above information shall be furnished within 07 days, failing which the defaulting State Dental Councils shall be held responsible for consequences thereof.
